

**California Real Property Journal  
Author Contribution Agreement**

Dear Prospective Author:

Thank you for your interest in publishing an article in the California Real Property Journal (the "Journal"), the official quarterly publication of the Real Property Law Section of the State Bar of California (the "Section"). As a condition of editing and publishing an article, the Section requests that each author grant and release the first-publication rights and non-exclusive reprint, republication, and distribution rights in print, electronic, or magnetic form including, but not limited to, third-party online databases, and other electronic publication and distribution media for any article submitted to the Section for publication in the Journal. The Section, through the Journal's editorial staff, sometimes receives after initial publication requests for article reprints. Also, the Section makes published articles accessible through the State Bar's website, third-party online databases, and other electronic and distribution media.

This granting of rights will not prevent the author from using the article after publication in the Journal. The author retains the copyright in the article, and the author retains all rights not specifically granted to the Section under this agreement. **Notwithstanding the foregoing, any reprint of the article by the author(s) after first publication in the Journal shall include the following statement: "First published in the California Real Property Journal, a quarterly publication of the Real Property Law Section of the State Bar of California."**

The person signing below warrants that: (a) he or she is the sole author and owner of all rights in the article and has full power to convey the rights granted; (b) the article has not previously been published, in whole or in part, except as disclosed to the Section in writing; (c) the article does not infringe any copyright or other rights of any party; (d) the article does not contain matter that is defamatory or that violates any party's civil rights, rights of privacy or publicity, or other legal rights, or that is otherwise unlawful; and (e) if the article reproduces any textual, graphic, or photographic material that is the property of any other party and for which permission is required for the Section to exercise any of the rights granted hereby, the contributor has obtained written consent from all such parties covering the exercise of such rights by the Section.

On behalf of myself and all co-authors and contributors, I grant the first publication rights to the Section for any article that I submit for publication in the Journal. I also grant to the Section the right to reprint, republish, and distribute any article that I submit to the Journal separate and apart from its initial publication in the Journal, in print and in electronic form including, but not limited to, third-party online databases and other electronic publication and distribution media. I understand that publication of my article in the Journal is not guaranteed merely by submission of my article, and that the editorial staff of the Journal will have final discretion as to whether and when to publish my article. I also understand that although the Journal's editorial staff will endeavor to work closely with me regarding both substantive and non-substantive editing of my article, editorial discretion is retained by the Journal's editorial staff regarding the final published article.
